SUBJECT	: New reporting/notification deadlines for RBS-F, Quarterly Statistics and Supervision purposes – Amending previous circulars		

The Cyprus Securities and Exchange Commission (the "CySEC") acknowledging the material challenges faced due to the outbreak of the coronavirus (COVID-19) in Cyprus and the uncertainty that this may have on the Regulated Entities' operations, wishes to inform the Regulated Entities, that a further extension of the deadlines for submitting the relevant reports/notifications to CySEC, will be granted as follows:

A. RBS-F Reports and Quarterly Statistics

Following Circulars <u>C363</u>, <u>C364</u>, <u>C368</u>, <u>C369</u> and <u>C370</u> issued about the electronic submission of the RBS-F and QST Reports, CySEC will extent the regular deadlines for the submission of the below listed reports **by three (3) months**.
