This can be very easily and conveniently done via ICPAC website <u>www.icpac.org.cy</u> (or through JCC smart- under the Member's subscription), in just a few moments.

Through the same flow, you can also update your personal details and complete / submit your annual CPD declaration for 2023 (if you haven't already), thus completing your renewal.

Please be advised that your annual subscription invoice will be sent to you by email on **January 5th, 2024**, with the due date for settlement being **31 January 2024**.

Should you wish to settle the renewal fee before receiving the relevant invoice, you can do so by filling in the notification for the renewal of the annual Member's subscription for the year 2024 form and sending it to <u>finance@icpac.org.cy</u>.

Keeping abreast of the obligation of the Institute and in line with the continuous improvement and enrichment of the services offered, it has been deemed necessary to increase the annual subscription from €180 to €200 for 2024, being the first such change since 2002!

It is also noted, that ICPAC look with care at the needs of its members, therefore the subscription for the members <u>who have completely retired remains at $\pounds 20$ </u> and for those members <u>who are proven to be unemployed remains at $\pounds 50$ </u>.
