Dear colleagues,

Please be kindly informed that the 63rd Annual General Meeting of the Institute has been fixed for Wednesday, 19th of June 2024 at 10:00am. The Annual General Meeting will take place at the Nicosia Municipal Theatre in Nicosia. The AGM will be held both with physical presence and with the use of electronic means, utilizing a special platform that has been prepared for this purpose.

At this Meeting **seven (7) members** of the present Council retire by rotation, namely Messrs Maria Pastellopoulou, Demetris Vakis, Petros Petrakis, Spyros Spyrou, Pieris Markou, Gavriil Onisiforou and Andreas Andreou, of whom Messrs. Pursuant to the Institute's Articles of Association:

- At the annual general meeting of the Institute every member of the Council who has completed three years' term in office from his last election to the Council shall retire from office.
- At the annual general meeting of the Institute every member of the Council who has served for four consecutive three-year terms in office (i.e. 12 years) shall not be eligible for re-election unless a year has elapsed from the day of his immediately previous retirement from the Council.
- At least four members of the Council must be practising members and at least four members non-practising.
- In no case more than two members of the Institute, belonging to the same Firm in the capacity of partner, shareholder or employee of the Firm, can be at the same time members of the Council.
- Every nomination proposal for election to the Institute's Council and every intention of seeking re-election must be delivered to the Institute's Secretary within a period of not less than <u>25 days</u> and not more than <u>45 days</u> before the date fixed for holding the Meeting.

Please find attached the related notification form which must be received in electronic format by the Institute within the above-mentioned period, that is, **not earlier than 5 May 2024 and not later than 25 May 2024.**
