Subject:	Annual Membership Subscription for the year 2020

Dear Colleagues,

Please find herewith attached the Notification for the renewal of the **annual Members' subscription for the year 2020**.

The renewal of the Members' subscriptions must be made by **<u>31 January 2020</u>** at the latest using the attached notification form and the payment of the subscription may be done by one of the ways mentioned on the form.

For speedier and more convenient transaction, you may elect to make the payment via the Institute's website <u>www.icpac.org.cy</u> or JCCsmart.

In the context of the continuous upgrading of ICPAC's services and digital transformation, the renewal of the annual subscription has been automated and thus an invoice will be sent by e-mail on 7th of January 2020, concerning the annual membership fee for the year 2020.

The Council decided to keep the annual **active members' subscription at €180 and for the fully retired members at €20**. Recognizing the difficult economic times, the Council decided to retain the subscription for the year 2020 at **€50 for those Members who are unemployed** (provided that they submit all the relevant documents from the Social Insurance Services).

Members' Benevolent Fund:

The purpose of the Members' Benevolent Fund of the Institute is to provide comfort to those Members and their dependents that face serious financial problems. This Fund requires reinforcement and we will appreciate it if you add your voluntary contribution to the attached remittance advice.

As per Regulation 6.100 (Renewal of Annual Membership Subscription), if any member does not settle his / her annual membership subscription by 30/06/2020, then the annual membership subscription will automatically be charged an additional charge equal to 50% of the amount of the annual subscription. Additionally, if by 30/09/2019, the member fails to arrange the renewal of his subscription and the additional charge, he or she will be automatically removed from ICPAC Member Registry.
